Rules: Please read this:

- 1) Absolutely nobody will be allowed to set up until after 4:00 pm on Friday night.
- 2) No tearing down before closing time, if you do, you will not be invited back.
- 3) The following items must not be displayed or sold:

Drug paraphernalia or items depicting the same

Weapons of any kind, including knives

Fireworks, pressurized string, odor products or obscene items

- 4) All vendors must have their area cleaned up and vacated by 7 pm on Sunday night.
- 5) Any tents need to be anchored. No stakes only sandbags or blocks in the street.
- 6) Booth space is approximate 10 x 10 deep.
- 7) You must furnish all equipment to set up and maintain your booth.
- 8) Sales and weather cannot be guaranteed. All vendors must be set up by 9 am Saturday and all vehicles removed from the street.
- 9) All day free parking is provided in the lot west of the Junior High. All campers and trailers will be parked across the street in the bus barn parking lot. A parking attendant will help you find space. No parking in the Handicap area unless you are qualified.
- 10) If it is YOUR company policy to have only 1 vendor at an event, it is YOUR responsibility to ask if anyone else is registered.
- 11) Registration deadline post mark is September 19, No registration will be accepted after that deadline.
